Fees for Medico-Legal Work – Dr Avie Luthra MRCP MRCPsych

Where a case falls under the Legal Services Commission, particularly for London, these fees are accepted and supplant those indicated below which are my normal fees.

The fee schedule below is for non-publicly funded cases. The fees for publicly funded cases from October 1st 2011 will be in line with those accepted by the Legal Services Commission.

The fee schedule below is for non-publicly funded cases. The fees for publicly funded cases from October 1st 2011 will be in line with those accepted by the Legal Services Commission.

Fees for Medico-Legal reports: The hourly rate for preparing medico-legal reports is £200 per hour. Fees are charged strictly on a pro-rata basis. Interviews with patients are generally for 2 hours. The typical period of reading and abstracting material from supplied documentation is 3-4 hours, and after this, 2-3 hours is spent in preparing and redrafting the final report. An average report would be about 8 hours of work, incurring a fee of £1600.

Shorter or longer pieces of work are charged accordingly.

Cancellation Fee for Medico-Legal Assessments: The fee charged for a patient not attending with less than 24 hours notice is for the full 2 hours of the planned interview time. Where it is possible to reschedule other clinical work to fill this time then the fee is reduced proportionately.

Travelling Time: £100 per hour plus First Class rail fare on public transport and, if necessary, local taxi fares.

Attendance fee for Conference with Counsel: £200 per hour of attendance. In addition travel time as above, and preparation time. Minor queries/correspondence incur no charge.

Fees for Attending Court: £1500 per day plus preparation time for giving evidence and travelling time. Preparation time is charged at £200 per hour. £750 per half day plus preparation time and travelling time.

Fees for Conference with Counsel:

A cancellation fee of 100% will be charged if cancelled within 24 hours of the Court date, 50% if cancelled within 3 days, and 25% if cancelled within 7 days.

Telephone discussions and small queries/other correspondence that takes less than 30 minutes will not be charged for. Longer pieces of work will be charged for at the hourly rate of £200 per hour.

Laboratory fees (charged at current laboratory rates): These are paid for by the Sloane Court Clinic and the laboratory invoice is presented for reimbursement. No handling charge is added to the laboratory fee.

Payment terms: It is requested that invoices are paid within 28 days of the day of issue.

VAT: Presently Dr Luthra does not need to charge VAT for the Medico-Legal work he undertakes.

Court taxation: It is understood and accepted that exceptional fees will be taxed by Courts.
