- At the Maudsley Hospital (2004-2009) I led the community forensic service, and at HMP Brixton (2002-2004) set-up the mental health inreach service and provided a clinical service in an extremely busy local prison covering the spectrum of psychiatric disorders from primary to tertiary care conditions.
